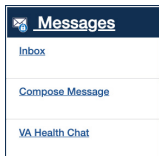

I kindly request a VA Community Care referral for IV Ketamine therapy through DOC'S Ketamine Clinic. Based on my medical record, it is evident that I have not achieved a full response to four adequate therapeutic trials of antidepressants, or my condition involves severe suicidal depression, where rapid treatment onset is crucial.

The National Protocol Guidelines for Ketamine provided by the VA states that a VA psychiatrist or a VA licensed healthcare provider can determine and document a patient's eligibility for ketamine treatment. Therefore, I kindly request your determination to allow me to receive appropriate treatment at DOC'S Ketamine Clinic, which has a Veterans Care Agreement (VCA) in place with the Southeast Region 3.

I request IV Ketamine over nasal spray because IV Ketamine is safer, more effective, and has yielded better results for patients.
